This seminar aims to address the unique challenges and opportunities faced by Chinese-speaking churches in the context of Singapore's national bilingual policy. Registry of Marriages (ROM): NCCS assisted in the processing of 70 new and renewal applications for member and non-member churches. Here are some information on Licence to Solemnise Marriages (LSM):

- 1. ROM's new policy: For Renewal of LSM, applicants may "wish to note that in reviewing the request for re-appointment, we will also take into consideration a number of factors, including the following criteria":
 - a. Continue to be leaders of the organisation and supported by Nominating Body (NB);
 - b. Satisfactory and no adverse public feedback;
 - c. No significant negative incidents reported; and
 - d. Be a role model for marriage, i.e. no adverse feedback on family/married life.

2. 2025 schedules

- a. New and Renewal LSM applications open on 1 October 2025.
- b. Submission deadlines for both New and Renewal Applications for 2026 will be 31 December 2025.
- c. Renewal of LSM: Licensed Solemnisers (LS) are to keep track of the expiry date of their own LSM. You may contact NCCS for renewal of LSM in October. Kindly note that the 31 December deadline for submissions is stipulated by ROM.

3. Reminder from ROM to Licence holders

- a. According to the terms and conditions set out for LSs & Deputy Registrars of Marriages (DRMs), the licence is only valid if the LS/DRM remains in the office through which his or her application was made. The licence is not transferable.
- b. When a licensee leaves the sponsoring church, the licence becomes invalid. When that happens kindly notify ROM and NCCS.
